

Green Nicotine Privacy Policy

At GN Development and Management (herein referred to as “Green Nicotine”), we value your privacy. Because www.greennicotine.com permits individuals to submit information via e-mail, we have developed this Privacy Policy to inform users of www.GreenNicotine.com of our policies and practices regarding such information. Green Nicotine is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to www.GreenNicotine.com and governs data collection and usage. By using www.GreenNicotine.com, you consent to the data practices described in this statement.

Collection of your Personal Information

www.GreenNicotine.com collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. www.GreenNicotine.com may also collect anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by www.GreenNicotine.com. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. This information may be used by www.GreenNicotine.com for the operation of its services, including our affiliate programs, to maintain quality of the service, and to provide general statistics regarding use of www.GreenNicotine.com.

Use of your Personal Information

Green Nicotine may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. Green Nicotine keeps track of the Web sites and pages our customers visit within www.greennicotine.com in order to determine what Green Nicotine services are the most popular. This data is used to deliver customized content and advertising within www.greennicotine.com to customers whose behavior indicates that they are interested in a particular subject area.

www.greennicotine.com will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on www.greennicotine.com; (b) protect and defend the rights or property of Green Nicotine; and, (c) act under exigent circumstances to protect the personal safety of users of www.GreenNicotine.com, or the public.

Use of Cookies

www. greennicotine.com uses "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. A cookie cannot read data off your hard disk or read cookie files created by other Web sites. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page.
